PRESIDENTIAL THOUGHTS Alan N. Baroody, President

A few weeks ago, I attended the Georgia Hospital Association's annual conference for regional hospital CEOs, board members and trustees. This was my fourth year of attending this conference, so I steeled myself ahead of time for two days of workshops on the Health Reform Act presented by lawyers who could put frenzied bedbugs to sleep. In order to survive, all hospitals are scrambling to standardize practices, become more efficient, and work to prevent re-admissions. With health reform, rather than profiting from re-admissions and unnecessary testing, hospitals will be penalized. To compensate for this, many are lowering costs by furloughing employees and increasing the workload on nurses and staff, thus making for a stressful and unhappy work environment.

One of the keynote speakers captivated my attention. Joe Tye, a coach for values-based leadership and cultural transformation, strayed from the usual doom, gloom, and glucose hospital talk and addressed the importance of developing a culture of ownership and compassion. At a time when organizations are trying to increase the bottom line by cutting staff, he emphasized the importance of developing a culture of compassion over the importance of strategic planning. Without developing a culture of ownership and compassion, strategic planning fails.

Developing a culture of compassion is something that we as marriage and family therapists know a great deal about. It is our compassion and ability to emotionally connect with others that draws clients to us and keeps them coming back. Yet, it is this same culture of compassion that can lead to our downfall. I don't know about you, but when I am with a client or couple and listen to their painful stories, I often visualize in my head the events they are describing. These are not pretty pictures, especially when talking with soldiers or survivors of trauma. Neurologist Andrew Newberg attributes this phenomenon to "mirror neurons", cells located in our brain's frontal lobe. They tend to react the same way whether you are listening to someone's story, watching someone do something, or doing something yourself. In other words, on some level, you experience what your clients describe.

Due to this, the work we do day - after day - after day leaves us susceptible to compassion fatigue which can be the result of secondary trauma plus burnout (definitions vary). Regardless of how you name it, I experienced it when I was in private practice in Denver – emotional exhaustion, sleep problems, stress related physical complaints, reduced personal accomplishments, depersonalization, etc. I didn't see it coming. It snuck up on me!

Dr. Eric Gentry (www.compassionunlimited.com) cites five "Antibodies" for preventing compassion fatigue and fostering resiliency: Intentionality, Self-regulation, Selfvalidation, Connection, and Self-care. I find that often we don't practice what we preach. Of the five anti-bodies above, the one that I want to emphasize is "Connection." Most of our GAMFT chapters meet quarterly. The meetings are primarily focused on providing a program with approved CEUs. My suggestion is that we make better use of our chapters. Many of us are Lone Rangers in private practice. Some are with agencies where time and workload prevent connection and interaction between therapists. Having GAMFT additional chapter meetings, or chapter support group meetings, solely for the purpose of telling our stories and taking care of ourselves, is a way in which we can support our colleagues as well as strengthen our organization. It would not be "just one more meeting to attend." It would be a way to connect and take care of each other. We have chosen a stressful occupation. Compassion Fatigue is something that, together, we can prevent.

DR. KENNETH HARDY – CHILDREN, FAMILIES AND TRAUMA: A RELATIONAL APPROACH Kathryn Klock-Powell, Vice President

It seems early to me to be thinking of the Spring Conference in St. Simon's. As I write this the temperature is around 30° which is certainly winter weather for Savannah! But I've been eager to be planning our annual foray to the beach where we can meet, rejuvenate, and connect with colleagues across the state while learning from a nationally recognized speaker.

STUDENT LOBBY DAY SET FOR MARCH 6 Carl Johnson, Chair Legislative/Governmental Affairs Committee

I believe that to succeed individually as marriage and family therapists, we must also succeed collectively; that is, in order to obtain jobs and grow our practices, we must work together to defend and advance the profession of marriage and family therapy. In large measure this involves being active politically – getting to know our representatives and senators, supporting those whose values we share and, when necessary, advocating with them regarding issues that affect the health and welfare of our profession. Certainly the social workers and, to a somewhat lesser degree, the psychologists understand this; their efforts over the years to advance the interests of their professions have positioned them well in the mental health marketplace. Those of us who worked to obtain licensure, privileged communication protection and insurance reimbursement for marriage and family therapists know this well. But if our profession is to remain strong we must pass this value on to the next generation of MFTs. To this end, in 2009 GAMFT joined with the social workers and professional counselors for our first combined Student Lobby Day. But it quickly became apparent that our issues were not always the same as theirs, and our smaller cohort of students were swamped by their much larger numbers. So, in 2011 GAMFT sponsored our first solo Student Lobby Day, which was an unqualified success.

This year we are again encouraging all GAMFT Student Members to join us at the Central Presbyterian Church, across Washington Street from the Capitol in Atlanta, from 9:00 am to 1:00 pm on Tuesday, March 6 for our second annual Student Lobby Day.

We will meet in the Brotherhood Room, off of Tull Hall. The program will begin with an explanation of the fundamentals of legislative advocacy and an outline of GAMFT's current legislative agenda. We will then go across the street in order to tour the Capitol and, wherever possible, allow the student participants to meet their legislators.

Learning how to be an effective advocate for MFT is an important part of being a member of this profession. I urge every student member to attend.

CALL FOR NOMINATIONS FOR GAMFT OFFICER ELECTIONS Elections Committee

The Elections Committee will present their slate of nominees at GAMFT's Annual Business Meeting, to be held at 8:00 a.m. on Saturday, May 4th, at the Spring Conference on St. Simons Island.

The first big change is that young MFT professionals are no longer Associate Members but instead Pre-Clinical Fellows. The Associate status remains, but, is designated for non-MFT young professionals in allied mental health professions. The biggest effect of this change is that Pre-Clinical Fellows have

the right to vote, whereas before that distinction belonged only to Clinical Fellows.

Due to this change in the Articles of Membership, the decision came during my tenure (as the Student/Associate Committee Chair), to sever the dual role of Student and Pre-Clinical representation. I believe that this separation makes sense as the needs of a student are far different than those of a

young professional. As a student in the Student/Associate position, it was difficult for me to imagine how to reach out and connect Associate members. In the same vein, in this past 6 months my connection to understanding the current needs of students is dissolving. Now that the Student Committee Chair is solely responsible for representing the concerns of fellow students, I believe the job will be more relevant and accessible.

I have truly enjoyed my time as the student representative and am excited to begin in my new role as the Co-chair of Legislative/Governmental Affairs. This position represents concerns that are dear to my heart and I am looking forward to working with and learning from my Co-chair, Carl Johnson. Students, I thank you for the opportunity to represent your needs over the past year. I am looking forward to watching your growth as young professionals as well as my own!
